A request for large load electric service will expire ninety (90) days after submission unless the Reimbursable Services Agreement has been executed and the required initial payment under that agreement has been received by the Cooperative, unless otherwise extended by the Cooperative in writing. Submission of this request does not establish queue position or priority for service, and the Cooperative reserves the right to evaluate and prioritize projects at its sole discretion.
